Disclaimer of liability

1.

As a participant of the 100MeilenBerlin I commit myself to follow the conditions stated by the organizer in the announcement and the briefing.

2.

I confirm that I have read, understood and accepted the announcement of the 100Meilen-Berlin.

3.

I am aware that the running course of the 100MeilenBerlin is not a specifically secured course and therefore I will be moving in open road traffic and have to abide to road traffic regulations. Any violation will be on my own responsibility and to my own disadvantage.

4.

I hereby assure that I am physically fit and have trained sufficiently for the race. I also have presented an attest to the organizer which confirms this from a medical point of view. The organizer assumes no liability for health risks related to the participation in the run.

5.

I already now agree to receiving medical treatment during the 100MeilenBerlin if a doctor deems this necessary in case I am injured in an accident and/or get ill during the race. I agree to pay the costs for medical treatment exclusively by myself.

6.

By participating I agree that the organizer, the host and volunteers will store all necessary data during the event and beyond in order to conduct the event. Data include photos, film and video footage taken during the 100MeilenBerlin, interviews in broadcasts, TV, advertising, books and photomechanical duplications. This also includes my name. There is no claim for publication.

7.

The liability of the organizer and the sponsors for their own actions and the actions of their legal representatives or vicarious agents is limited to intention and acts of gross negligence. This does not apply to damages based on injury of life, body or health. In this case statutory regulations apply.

Included are all direct and indirect damages and all claims the participant, their heirs or other entitled third parties could allege based on suffered injuries or in case of death.

I also keep the organizer, the hosts and volunteers indemnified against all liability towards third parties suffering damage due to my participation in the 100MeilenBerlin. I have to bear all costs incurred.

I am aware that the participation in the 100MeilenBerlin is potentially dangerous and that the risk of severe injuries up to lethal accidents and damage of property cannot be eliminated.

11.

I am aware that if my conduct during the race conflicts with the process of the race or damages the reputation of the 100MeilenBerlin, I can be disqualified, and if my conduct causes damage I have to bear all costs incurred.

12.

In conclusion I declare that I have read this disclaimer of liability thoroughly and in detail and agree to all points included.

13.

Should any of the above regulations prove to be void or unfeasible or become void or unfeasible after completion of the contract, the other regulations of the contract remain unaffected. The void or unfeasible regulation(s) shall be replaced by effective and feasible regulation(s), which will best serve the economical purpose originally intended by the void or unfeasible regulation. The above regulations apply accordingly in case the contract proves to be incomplete.
